- > Half the size of Czechia, almost double amount of people
- > 8 UMCs, 98 general hospitals, 147 outpatient clinics
- > Mandatory basic health insurance
- > Health Care Institute determines what health care is insured
- > Health Care Authority determines maximum prices

- Kinderziekenhuis (7)




Top 10-lijst sterfte op basis van doodsoorzaken in 2021



Top 10 list of disorders based on health care spending 2019




